Nothing new on pay – due to the Gen Election and we are now approaching Government recess for the Summer. Work continues on revision of the all-Wales Disciplinary Policy and on the all-Wales Job Evaluation policy. There are a number of JDs earmarked for development including for FCP. Watch out for a new 'Flexible Retirement Policy' (due for imminent publication) and an important 'Pregnancy Loss' Policy. **To Note.**
